

## **Confirmation of previous AGM Minutes**

• Robin Dzedins proposed the minutes of the 2015 AGM be accepted. Seconded by Kristian Goree. Passed unanimously. Copies of the Constitution were handed out to attendees.

#### **President's Report**

Christopher Morgan thanked Casey Council for the new Community Centre where the AGM was being held for the first time. Thanked previous Presidents and the local community, and Mike Tyler and all the workers at Casey Council for being so good to work with once again during the year.



He then listed the achievements of the LRA over the year:

- ALS Ice Bucket Challenge with Hampton Park CFA
- Nomination for Event of the Year by Casey Council
- Reference Committee for the Community Centre
- Persuading Casey Council to reverse its position on Northey Road closure
- Introduction of a new Constitution in line with Victorian Govt best practice
- Assisting with the official opening of the Community Centre
- Working with many organisations, including: the CFA, Lions Club, both Lynbrook Primary Schools, Livvi's Place, Local Businesses, Hampton Park CRG
- Co-operating with Lynbrook Primary School to share equipment for each other's events
- Keeping the Community informed about the things the LRA have done via the http://lynbrook.org.au website, Facebook Group, Posters and Emails
- Advocating on behalf of the community to various organisations, with special mention and thanks, regarding the great relations the LRA have with Casey Council
- Petitions to Council raised by the LRA (in particular Suz Arnott) have been successful, and will result in new facilities in Banjo Paterson Park
- LRA advocacy over the years has resulted in a grant for playground equipment in Kingsfield Reserve
- Attempts to resolve issues with funds previously pledged to the Community
- Obtained an agreement with the Council that the LRA can store equipment in a special area in the Community Centre. We are very grateful for this
- Liaison with Anthony Byrne, our local Federal MP, regarding the LRA's existence, and discussions regarding Funding awareness

Christopher then listed the events the LRA had organised and run during the year:

- Lantern Festival (with an estimated attendance of 5000 people)
- Christmas movie and Carol evening
- Clean up Australia Day
- Holi Festival

- Inaugural Winter Talent Showcase at the Community Centre (with ~\$1000 in prizes donated by local businesses)


## Sponsors:


## Guest Speaker - Presentation by Mike Tyler, CEO - City of Casey

Mr Tyler gave a highly informative presentation to the LRA members and attendees. Mike has provided the LRA with a softcopy of his presentation, which will be placed on the LRA website (http://lynbrook.org.au). Highlights were:

- Mike has been the CEO of Casey Council since it's inception (over 20 years), and has worked for the Council (including it's predecessor for 30 years)
- The population of Casey was 135,000 20 years ago and is now 295,000 and is the most populous (as well as the "most reproductive") Council in Victoria
- Annual budget is \$339M and Capital Works budget is ~\$130M/year
- Debt is \$12.5M which is comparatively very low at 6 ½% of rate revenue.
- Mike believes that Casey should have special financial assistance from the Government, as it is disadvantaged because it's a high growth council.
- Rates are low in comparison to other councils (more info in presentation).
- Staff engagement ratings are very high, and improving all the time
- Bunjil Place will be a fantastic community precinct, and the Council have recently appointed Brookfield Multiplex to build the project, and it's scheduled to be completed Oct 2017
  - ▶ Cost is \$125M. \$10M from Federal Govt, \$85M from borrowings, \$10M requested from State Govt, and the rest from specific reserves held over the years
- One of the issues for the area is that due to the huge population growth, there are jobs needed in the region
- Thompsons Rd construction will allow links to Eastlink and other roads, and this will potentially help job availability and wider access to more places of employment
- Evans Road is closed to through traffic due to Vic Roads concerns about intersection safety

Mike took questions from the audience:

Q: What about opening Evans Rd to allow just a left turn on Sth Gippsland Hwy from Lynbrook? A: Mike will ask Vic Roads about this.



Q: How long until Glasscocks Rd is open all the way through? A: Mike would be surprised if it's open in 20 years.

Q: There are issues with non-complete footpaths in the Lynbrook area, in high traffic areas. What can be done?

A: Mike suggested writing to the Council with specific issues – especially on Henry Lawson Dr.

Q: Can the Council do anything about issues with the Lynbrook Hotel and it's previous pledge to Community organisations?

A: Probably not. This issue has come up in the last with another organisation.
